

All-Nebraska captain went 23-3 and batted clean-up

It's an almost brand-new crew of players - a nice blend of seniors and youngsters — that make up the 19th World-Herald All-Nebraska softball team.

Ten of the 13 players honored - eight from Class A and five from Class B — are being honored for the first time. The two repeat selections are University of Nebraska mercuits — Papillion-La Vista sophomore outfielder Gina Metzler and Beatrice senior infielder Alicia Armstrong.

Lincoln Southwest's Tania Carroll also is being honored for the second time as an outfielder after she was an All-Nebraska pick in 2009.

Just more than half of the first- and second-team selections -14 — are from Class A, with Class B landing 10 spots and Class C the other two.

Seven seniors, three juniors and three sophomores are honored on the first team, which is based on nominations by coaches and observations of World-Herald writers. There were four solid candidates for honorary captain

pitchers Taylor Erlenbusch of Millard South and Kaylan Jablonski of Omaha Skutt, Armstrong and Lincoln South-west infielder Liz Dike.

Erlenbusch was selected because when she was asked

to do even more than she had the past two years, she sim-ply led the Patriots to their second Class A state title. "That's what puts her over the top," Millard South coach Steve Kerkman said. "If we didn't have Taylor, we wouldn't have had the season or success we had. Instead of being the co-No. 1, she had to be the No. 1 pitcher for us."

The Patriots (29-3) won 25 of their final 26 games and went undefeated in six postseason games. It's well-docu-mented that Erlenbusch would be responsible for almost all of Millard South's innings because Chrissy Harris was sidelined until the final week of the season with an injury.

Erlenbusch was 23-3 with a 0.87 ERA. She had 12 shutouts, four one-hitters and a perfect game against Omaha Westside in the first round of the Class A state tournament in Hastings

In the Class A championship game, Erlenbusch allowed just one earned run in the Patriots' 6-2 victory over South-

Kerkman said he realized just how much this season meant to Erlenbusch when she took a no-hitter into the seventh inning of a 1-0 victory Sept. 22 over Papillion-La Vista South. She had 15 strikeouts to lead the Patriots in avenging one of their three losses

"You kind of got the feeling at that point that if she can persevere, we've really got a good shot (of winning state)," Kerkman said

Erlenbusch battled back problems and migraine headaches through her high school career. Kerkman said she never used those ailments as an excuse.

"The ability for her to play well was never a question," Kerkman said. "You just never knew when her back would hurt or a migraine would flare up. Even when they did, you could never tell."

As the Patriots' clean-up hitter, Erlenbusch also did plenty to help her pitching performances. She hit .410 with an on-base percentage of .438, but teams still occasionally would intentionally walk catcher Blake Ringle to get to

her. "There would be a few teams not pitch to Blake in the three-hole," Kerkman said. "She took that personally."

State title is Patriot redemption

HASTINGS, Neb. — Millard South softball players have a stockpile of sayings they like to

call Kerkmanisms. These gems of wisdom from Patriots coach Steve Kerkman have found their way onto a team T-shirt.

After Friday's 6-2 victory over Lincoln Southwest in the Class A state softball championship game, Patriots pitcher Taylor Er lenbusch has another one to add to the collection.

"We never let a team beat us twice," Erlenbusch said. "What a way to go out, redeeming our-selves like that."

The Silver Hawks defeated the top-ranked Patriots 4-1 on Oct. 1 at the Millard South Invitational. Both Kerkman and Erlenbusch said the team was timid at the plate that day.

plate that day. There was nothing passive about the way Millard South's offense attacked the 38-7 Silver Hawks in Friday's tile game at the Smith Softball Complex.

After second-ranked South-vest went up 1-0 in the top of the first inning - two Millard South errors helped shortstop Liz Dike score that run - then left the bases loaded without scoring again in the second, everything started to go the Patriots' way beginning in the bottom of the inning.

29-4 Patriots took the The ad for good when left fielder Meg Mumaugh ripped a two-run double to left field after Rachel Kubik started the inning with a single. But Kerkman said his team wasn't completely comfortable until the later innings.

"We were down 1-0 in three straight games so we were OK," Kerkman said. "In the middle in-

nings, they didn't want to be the one to make the mistake. In the last couple of innings, they got after it and were more comfortable at the plate." Erlenbusch also settled into

her groove in the circle and cooled off the Southwest bats that had scored 28 runs in three elimination-bracket games after 9-8 loss to Papillion-La Vista on Thursday.

Southwest earned its berth in Southwest earned its berth in the championship game with a 13-5 victory over Papillion-La Vista. Dike had a grand slam in the second inning and a two-run home run in the seventh to lead the Silver Hawks' 11-hit attack

"We got a run early and got off to a good start," Southwest coach Mark Watt said. "They made their own offense after that and just swung the bats better."

Not only was Erlenbusch the pitcher Millard South leaned upon the past two months, she also came up big at the plate. Her double to lead off the fifth inning led to the Patriots' fourth run, and a sixth-inning single led to Millard South's last run.

That's what Kerkman said his

ace has been doing all season. "She proved it," Kerkman said. "She carried it all the way. She's a student council kid, she's in hon-

or society, she's just a leader." Erlenbusch said this title — Millard South's first since 2005 was a complete team achievement.

"We faced a lot of adversity this year," Erlenbusch said. "We redeemed every loss and came in and took control when we needed to.
